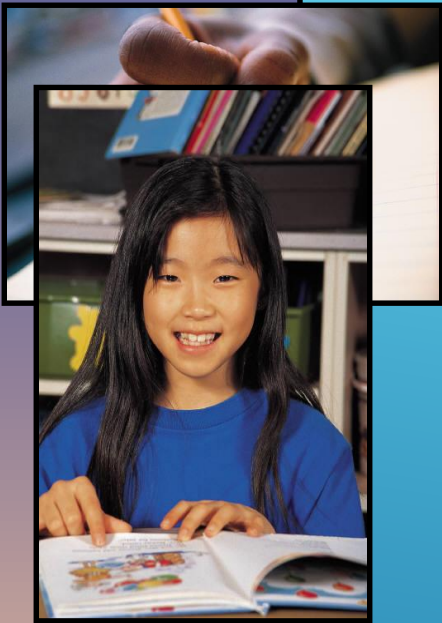

CERTIFICATION UPDATE

Recent Changes in Requirements (Implemented):

Professional Teacher Certification

- All Teachers Issued Professional Certificates After September 1, 2014 Will Renew by 4 1-Year Professional Growth Plans (PGP) in a 5 Year Period
 - Teachers Issued Professional Certificates Prior to September 1st Will Have a Choice (150 Clock Hours or PGP)
 - Continuing Certificate Holders Will Have Choice (150 Clock Hours or 4 PGPs in a 5 Year Period)
 - A PGP will Equate to 30 Clock Hours
 - For Those Eligible (Above Requirements) Educators May Combine PGPs and Clock Hours and Will Need to Meet Accumulative 150 Clock Hours

CERTIFICATION UPDATE

Approval to Draft Language for Certification Requirements at the Upcoming Professional Educator Standards Board Meetings in November and January:

Reinstating an Expired Professional Certificate

- Draft Language Will be Presented Requiring at Least 2 PGPs and College Course Work or Clock Hours to Equal a Total of 150 Clock Hours to be Completed for Renewal

Teachers Holding Identified STEM Endorsements

- Draft Language Will be Presented Requiring 15 Clock Hours or Half of One PGP With Emphasis on STEM Integration to Meet Renewal Requirements

CERTIFICATION UPDATE

Approval to Draft Language for Certification Requirements:

Professional Growth Teams

- Draft Language Will be Presented Reducing the Current Size of a Professional Growth Team from Four to Two, the Individual and One Certificated Colleague
- Draft Amendments Will be Presented for Additional Language Citing the Definition of a Professional Growth Team in Other Sections of WAC for Clarity and Alignment

Bilingual, English Language Learner, SpEd, Early Childhood SpEd

- Draft Amendments Will be Presented Requiring a Second Content Endorsement for Teachers Earning the Above Endorsements
- Out of State Applicants Will Have Two Years to Add the Second Endorsement

Approval to Draft Language for Certification Requirements:

School Psychologists

- Draft Language Will be Presented for Consideration on Whether Residency School Psychologists Should Be Allowed to Earn a Professional Certificate by Using a PGP to Meet Benchmarks
